

## ANNEX TO THE BOOKING CONFIRMATION (JOSPED LTD. Terms and Conditions)

### Terms of payment:

The full amount of the freight invoice is due within 30 days after the invoice date, if nothing different agreed. All bank fees and commissions should be paid by the originator of the transaction. The freight costs do not include VAT.

4/4 hours for loading-unloading are free of charge. After the expiration of the time free for loading we have to charge you a demurrage amounting to 150 EUR per truck and per started day and night.

Dangerous goods – all transport documents should be properly filled in and the commodity should be properly packed and marked according the ADR regulations.

### Additional remarks:

Upon exceeding the gross weight of the cargo specified in the requisition and/or the bill of lading (CMR), or in case of uneven load, leading to an excess of the normatively allowable total weight or axle load, all fines and additionally occurring expenses as a result thereof are for the account of the client indicated above.

For maximum protection of the interests of all parties interested in the cargo, we recommend:

1. The one who performs the loading is to ensure, by means of a locking device or direct surveillance, the inviolability of the cargo from the time and place of loading until the placement of a seal (if the cargo is found under customs regime or if the seal is placed as a voluntary security measure), or until leaving the loading point.
2. The one performing the loading is to personally verify that the seal is placed properly and effectively.
3. The exporter has an obligation to duly fill in an electronic customs declaration, incl. all security and safety attributes. Otherwise, any occurring expenses are for the client's account.

### General conditions:

Our rates and tariffs consider the valid tariffs, currency exchange rates and other price-building costs at the moment of the quotation. The transport costs and the road toll are included in our tariffs, but we have not included additional costs which occur and do not depend on us as cargo insurance and demurrage. Please consider that the freight costs and-or the costs related to the transport should be paid by you.

Josped Ltd. recommend to you to make a cargo insurance of your shipment during the transportation for the full amount of the cargo, because the liability of the carrier for roadfreight transports is limited to 8.33 SDR (Special Drawing rights) only per kg gross weight and can not exceed total value of the cargo.

All additional agreements, changes in the above mentioned conditions, terms and annexes will be applied only in a written modus.

We work according the currently valid legal frame of the Bulgarian Law and the International Law. All disputes should be solved between the parties according an agreement. In case this is impossible the disputes should be addressed to the court in charge in Sofia, Bulgaria.
